



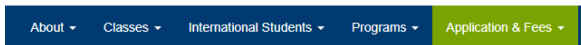

● UC Berkeley Students

REGISTRATION STEPS:

1. Complete the Berkeley Summer Sessions application
 - a. Applicants must login or create an account to access the application.
 - b. Documentation to meet the [English Proficiency Requirement](#) is required with the application unless exempt. *The Duolingo test can be completed online with results in just 2 days.*
 - c. There is a \$25 non-refundable application fee.
 - d. For any questions or issues with the application, students may contact summer@berkeley.edu.
2. Establish CalNet ID and access CalCentral
 - a. After completing the application, applicants will receive email instructions with their Student ID number within 48 hours.
 - b. For CalNet ID support, students may contact calnet2-stephelp@berkeley.edu.
3. Enroll in [Classes](#) via Calcentral
4. Submit [COVID-19 Vaccine Documentation](#)

- a. All students must provide proof of compliance with this mandate or be approved for an exemption before the start of their classes.
 - b. Students will see a task item in CalCentral; here are instructions on [how to upload proof of vaccination](#)
 - c. For any questions about the vaccine requirement or documentation, students may contact the University Health Services at tbimmune@berkeley.edu.
5. Submit I-20 Request via International Student Services (ISS) Portal
- a. International students will have a CalCentral task item with a link to complete the I-20 request form.
 - b. For any questions about visas, the I-20, or immigration status, students may contact visiting-intl@berkeley.edu.
6. Students must pay the tuition and fees within 7 days of enrollment, or they will be dropped from classes for non-payment.

HOW STUDENTS AFFILIATE THEMSELVES:

Students must affiliate themselves with your institution in the Summer Sessions application; otherwise, they will not be eligible for any affiliate benefits, including early enrollment.
