#### STEM-DESIGNATED PROGRAM

Students will engage with a program that is STEM designated, which recognizes the rigor of the business school's academic programs across a number of fields including analysis and forecasting, statistical modeling, data analysis, financial simulation methods and more. Additionally, the designation enables international students to extend a 12-month practical training experience after graduation by an additional 24 months.

#### **DATA ANALYTICS**

Dive into the story behind the numbers and develop sophisticated technical analysis skills in data science. The Data Analytics concentration prepares students to communicate, strategize and interpret decisions in business, economics and finance using big data. Applied coursework focuses on forecasting, system dynamics, financial modeling and design marketing.

Careers: The application of data analytics extends to the fields of economics, marketing, pricing and consumer behavior, investments, statistical analysis and more. Brandeis IBS graduates have secured data analytics positions at companies including Moody's Analytics, Legal Aid Society, Infor, Walt Disney Parks & Resorts and Mather Economics.

#### FINANCIAL ECONOMICS

Explore the impact of investments as they relate to government policies and the global economy. The Financial Economics concentration prepares students to analyze, develop and communicate complex investment and economic decisions across corporations, governments, central banks and financial institutions.

Careers: Opportunities in financial economics are bountiful, with applications in investments, central banking, public policy and hedge funds. Graduates have been successful in launching careers in a multitude of industries at the intersection of economics and finance. Recent graduates have gone on to work for companies including Goldman Sachs, TD Bank, State Street Global Advisors, JPMorgan Chase, HSBC, the Federal Deposit Insurance Corporation (FDIC), Capital One, Bloomberg and BNP Paribas.

The Marketing concentration prepares students to explore the practical application of integrated marketing plans, communications strategy and strategic analyses in the context of economics, finance, business and global politics.

Careers: Marketing has career applications in nearly every industry. For MA graduates, recent fields include digital advertising, startup management, sales and operations, project management, development and brand management across various industries including fashion, pharmaceuticals, banking, higher education and more. Brandeis IBS graduates currently work in marketing positions at companies including Capital One Financial Corporation, Facebook, Merck, NetBrain Technologies and Habitat for Humanity.
